### THE BENEFITS OF DONATING STOCK\*

**Please contact us for information on how to make a Donation of Stock to our Fidelity Account. , Here is some information on how this BENEFITS YOU!**

**1) Donors Save on Taxes:** By donating stock rather than selling it, donors avoid paying a capital gains tax. A capital gains tax is a tax on the profit made from the sale of a non-inventory asset like stock.

**2) Donors Take Charitable Deductions:** If they donate long-term holdings (stocks held more than one year) and itemize deductions, Donors can take a charitable deduction for the stock's fair market value on the day they give it away.

**3) Decrease Future Capital Gains:** If stock is currently at a higher value, Donors can decrease future capital gains by donating stock and buying new shares.
